CAC 2020 Dues at Year-End

This summer, we shared how the pandemic has increased the need for civil legal aid services, while at the same time overwhelmed public defender offices. In response to that unprecedented level of need, NLADA and CAC partners have been fighting to protect and increase funding for critical legal services. But the need for our help continues to grow and we need to do more to support civil legal aid offices and public defender programs as they respond to today's ever-growing challenges. Currently, your annual CAC dues are \$5,500, which we greatly appreciate! However, as we face the growing COVID-19 pandemic and subsequent economic fallout, while responding to longstanding and pervasive racial inequality, we need additional funds to effectively do this work. We are asking that you please consider a one-time fully tax-deductible addition to your dues of at least \$4,500, bringing your unrestricted contribution to NLADA to \$10,000. 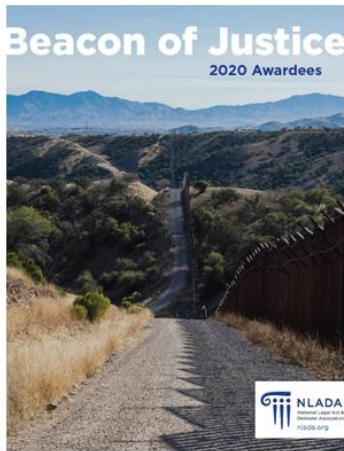


Business Advancing Justice: The Goal 16 Working Group
