For more than 114 years, the National Legal Aid & Defender Association (NLADA) has fought to make the promise of equity and justice real for every person who stands in need of legal counsel in America, regardless of income, background, or zip code. But today, that promise is under threat.

**JustFundIt** is a national campaign to protect and expand federal investment in communities and families to ensure equal access to justice in America. As funding uncertainties and executive actions jeopardize the stability of families and communities, **NLADA is sounding the alarm and mobilizing action.**

**Over 90% of criminal defendants** need a public defender to protect their rights and freedom.



The overwhelming majority of clients served by civil legal aid and public defenders rely on federally funded programs, such as Medicaid, public benefits, housing, and educational resources.

**NLADA members fight every day to protect communities and restore their access to benefits, education, Medicare, and due process.** And yet, funding for communities and families remains drastically under-resourced. That's not justice. That's an injustice for the most vulnerable communities.

### **3. Questions to consider when telling your story:**

- Tell us briefly who you are (a mom, a student, which state you live in, etc.)
- Who helped you with your case, a public defender or a civil legal aid organization?
- How did your lawyer (and their office) help you? Why were they important to you?
- What might have happened if you hadn't had access to an attorney and how would that have affected your life?
- Is there anything else you want policymakers to know about the importance of preserving legal services and other supports for your community?

## We Need Your Help. Contact Your Representative.

Use the following information to contact your senators and representatives asking them to protect federal funding. If you have personal experience with civil legal aid, please consider sharing your story with members of Congress. If you support civil legal aid but do not have personal experience, tell members of Congress why civil legal aid matters to people in your community.

**CALL YOUR MEMBERS.** You can call their direct lines, listed on their webpages through the links above, or you can call the US Capitol Switchboard at **(202) 224-3121** where an operator will assist you. If you are unable to speak directly with anyone in your Member's office, leave a voicemail.

The call script below may help you plan what you would like to say to them:

I am a constituent from [Senator/Representative name]'s [state/district] from [name of your city/town] calling to urge them to protect federal funding for Legal Aid. Cuts to this program would cause millions of Americans nationwide to lose access to Civil Legal Aid which protected due process. Due process ensures that people have a fair chance to be heard in legal matters that affect their lives. I strongly urge the Senator/Member to protect this lifeline and oppose cuts or harmful policy changes that would threaten people's ability to access Civil Legal Aid. We need legal aid to protect access to public benefits such as housing, food, and health care that keep families stable and out of crisis. **ATTEND A TOWN HALL.** When Members are not in Washington, D.C., they often hold town halls in their districts. Check their websites for information about upcoming events. Also, most every member of Congress has a newsletter you can sign up for to stay up to date on their scheduled events and actions, including town halls.

If you attend a town hall, below is sample language you can use and adapt when speaking:

I am one of the millions of Americans that rely on legal aid to stay housed, employed, safe and healthy. [Insert 1-2 sentences of your personal story about how civil legal aid helped you] I believe in our constitutional right to due process. Will you commit to protecting civil legal aid, and programs and services like housing, Medicaid, SNAP and other public benefits by voting against any budget bill that includes funding cuts or other harmful changes to these programs and Civil Legal Aid?

### Understanding the Federal Budget Process:

The federal government is divided into three major branches: The Executive Branch (White House and federal agencies), the Legislative Branch (Congress), and the Judicial Branch (federal courts). Congress has authority over federal funding, often referred to as the “Power of the Purse.” Federal funding is broken down into two major categories.

The first is Mandatory Funding. This includes so-called “entitlement” programs for which hundreds of thousands of people qualify, including Medicaid (health care), the Supplemental Nutrition Assistance Program (SNAP or “food stamps”), Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI), among others. Changes to these programs may occur during the “Reconciliation” process, which is taking place right now. View an infographic about Reconciliation [here](#).

The second category is Discretionary Funding. This often is referred to as the annual appropriations process and provides funding for each federal fiscal year, which begins October 1. It includes appropriations for many government programs at an amount set by Congress every year, including funding for the federal agencies like the U.S. Departments of Education (ED), Health and Human Services (HHS), Housing and Urban Development (HUD), Justice (DOJ), and others, as well as the Administrative Office of the Courts and the Legal Services Corporation. It also includes funding for many programs that goes to state and local governments and nonprofit organizations across the country. The annual appropriations process begins in every spring and has begun for FY 2026. Safe and affordable housing is the bedrock of stability and allows people to live healthy lives, with access to education, employment and community. The U.S. has a shortage of 7.1 million rental homes affordable and available to renters with extremely low incomes, and shifts in federal policy, both through the executive branch and in Congress threaten to widen that gap.

### **Want to learn more about due process, civil legal aid and public defense?**

The constitutional right to due process is enshrined in the Fifth Amendment. What it says: *No person shall be deprived of life, liberty, or property without due process of law.* What it means: the government may not take away life, liberty, or property from anyone *without reasonable notice and a meaningful opportunity to be heard.* This means that when the government takes action to imprison someone, or denies them benefits for which they are eligible, or denies them custody of a child, it first must give notice *and* that person has the right to state their case (for example, appeal, in the case of public benefits).

Civil legal aid and public defense advocates exist to ensure that this constitutional right is observed and met. Every day, they ensure people in criminal proceedings are able to defend themselves against the strong arm of the government, and that people in civil proceedings can access housing, benefits, education, employment and so much more. But these legal advocates are vastly underfunded and current proposals seek to make this so much worse.
