# **Conspiring Better Together: The Case for Collaborative Defense**

As people who have chosen to lend their hearts and minds to the cause of public defense, we often see ourselves as our clients' most vital and fiercest champion. But when it comes to the daily life of practice, all too often the scope and urgency of our clients' needs can prove overwhelming, especially in an under-resourced and over-extended work environment. We want to do more, but it feels like we are forever doing more with less. This session will focus on how re-aligning our work through a client-led lens can open up new, adaptable, and innovative ways of fighting for our clients' needs both inside and outside the courtroom. We will outline a theory of collaborative defense, illustrating what successful interdisciplinary practice can look like, and showcasing some immediate things offices can do to strengthen their ability to operate as a client-led collaborative defender. We will conclude with a vision of what this new framework can do to expand how public defenders are valued and defined by both their governments and communities. • Thou Shall Not Ration Justice: The Need for Civil Representation for Persons Involved in the Criminal Justice System as a Basic Requirement of Equal Justice

The place and role of civil legal assistance in an indigent criminal defense model is a subject that should be at the forefront of any discussion of reimagining justice. This workshop is founded on the premise that equal justice demands that public defenders and civil legal services providers must understand the direct and immediate relationships entwined among the criminal legal system, race, poverty, and injustice, and the need to build into their respective practices models of representation that address client needs beyond liberty, guilt, and innocence. This workshop will include a discussion of how PDS's model of indigent defense has incorporated civil legal assistance, how it operates in practice, its strengths, its shortcomings, the various delivery models that are available, and a number of the unique issues that face the provision of civil representation to persons involved in the criminal justice system. We will explore what the constituent elements of such a civil practice anchored to an indigent defense model should include and provide thoughts on the importance of building crosscultural/organizational relationships between indigent defense programs and civil legal services providers. We will share a few practice aid documents that are important to practicing at the intersection of criminal defense and civil representation and others that illustrate the contours of this advocacy.

• The Power of Visual Storytelling: How Video Mitigation Can Transform Your Advocacy

Mitigation videos humanize and add depth and nuance to those being represented within a system that strips them of their humanity at every step. They bring to life people's personalities, backgrounds, and complex lives in a way that the written word cannot. The viewer, whether it's a judge or a prosecutor, gets to know the person's family, surroundings,



traumas, and issues in a way that a few paragraphs or photographs cannot accomplish. The video also presents the future - where the person standing before them will live, who will support them, what treatment and/or community support they will engage in, and why the person should receive a more just outcome than prison.

The workshop will be in a participatory format to enable participants to gain a thorough understanding of what video mitigation is and how the participant could employ this strategy in their own practice to gain justice for their clients.

The workshop will be in two parts: The first will present the concept of video mitigation, how it concretely works, the method a smaller public defense organization could implement, and how a solo and a law firm could utilize video mitigation. We will also present video clips from actual cases where our clients have provided releases.

The remaining 30-60 minutes will be divided into four breakout rooms where our team members will work with one to two participants to develop a plan for a mitigation video. The case may be a hypothetical case, or it can be an actual case the participant brings to the presentation. We will develop the video using a workflow we have created, covering theories of a case, story arcs, potential interviewees, pre-production, production, and distribution strategies.

The participants will leave the presentation with the theoretical framework of video mitigation and concrete tools to use this model in their practice to achieve justice for their clients.

# • Transforming Siloed Data into Actionable Data to Advance Racial Justice

Mecklenburg County, North Carolina, is one of the nation's leaders in pursuing evidence-based justice policy and practice. Over the past few years, the County has implemented a series of sweeping pretrial reforms to help inform the courts' decisions about pretrial release. The County also has an Equity Action Plan goal that all residents live in a more just and equitable community, along with a primary strategy of reducing racial disparities and disproportionality within the criminal justice system.

To monitor and evaluate the pretrial and equity reforms, the County partnered with Luminosity, Inc., to transform siloed data from independent justice system agencies into usable, accessible, interpretable, and actionable data. The interactive dashboards tell the story of how people are processed through the pretrial justice system, from law enforcement contact until case resolution. There are a set of dashboards designed to view the pretrial justice system through an equity lens. The dashboards are intended to be used to monitor system performance in real time; empower strategic and data driven decisions; increase transparency and accountability; and illuminate actionable insights.
